1. Introduction

Welcome to the COPS Office grant program! This guide will provide you with vital instructions and information to get you oriented to your COPS Office grant. In addition to describing the quarterly reporting process, it will also explain how to draw down your funds and provide other facts and information regarding monitoring and managing your COPS Office grant.

2. Your Grant Information

To get started, you will need the information specific to your COPS Office grant that states how much funding you have received and how the money should be expended. You will need to gather the following documentation:

- Award document, which identifies the grant type, grant number, award amount, and award period
- Financial clearance memorandum, which includes the approved budget breakdown
- SF-425 Financial Report, which includes the status of expenditures
- Payment History Report from the Grant Payment Request System, which lists the funds that have been drawn down
- The Grant Owner's Manual for your specific grant
- The terms and conditions section of the grant award package

3. Administrative Items

Gaining Access to COPS Office Systems

To use your grant, you will need access to two key systems. The first is the COPS Office's Agency Portal, which will allow you to update agency contact information and perform other grants management functions, including modifications, extensions, and grant withdrawals. The portal is where you will go each quarter to submit your federal financial report (SF-425) and programmatic progress report. The second system you will use is the Grant Payment Request System (GPRS), which is how you will draw down your funding.

COPS Office Agency Portal

The User Moderator or Law Enforcement Executive (LE) must add you to the Agency Portal user pool. If you are having trouble with this, contact the COPS Office Response Center at 800-421-6770.

To register a new user:

1. After the user logs into the Agency Portal, the system will display the **Agency Portal Home** page. From the **Agency Portal Menu** on the left, the user selects **Agency Users**.
2. To add a new user, the user selects the **Add** button. If the user is not the Law Enforcement Executive (LE) or Government Executive (GE), then the user must first establish the LE/GE's account, roles, and permissions.
3. Once the user selects the **Add** button, the system will display the **Add/Edit User** page.
4. First, the user will complete the required information in the top section (i.e., the new user's e-mail, title, name, etc.). Second, under the **Agency Portal** section, the system will also require the user to assign you, the new user (i.e., assignee), the appropriate role(s) by checking the desired box.
 - a. **Agency Moderator** – This role allows the assignee to create, edit, and/or manage the agency information, such as LE/GE information, agency address and phone and fax number.
 - b. **User Moderator** – If the LE/GE assigns this role to another user, that user can manage agency user information, such as adding or deleting users and changing user permissions and contact information. However, the assigned User Moderator cannot edit his or her own information; thus, he or she will need to ask the LE/GE to do so.
 - c. **Law Enforcement Executive (LE)** – This role should be reserved for the LE as this role provides signature access for grant documentation.
 - d. **Government Executive (GE)** – This role should be reserved for the GE as this role provides signature access for grant documentation.

Only one user should be assigned the LE role, and only one user should be assigned the GE role. Third, beneath the **Agency Portal** section, the user must check the permissions boxes associated with the various system applications (e.g., progress reports, SF-425, and COPS Application Program) to which the assignee should have access. Last, once the user has established the roles and permissions for each new assignee, the user selects the **Update** button.

5. After the user informs you (the assignee) that your account has been created, you must then visit the **Agency Portal Login** page (Figure 1), click the **Reset Password** link and follow that page's instructions.

Grant Payment Request System (GPRS)

To register as a new COPS award and GPRS user:

1. Go to the GPRS login page at <https://grants.ojp.usdoj.gov/gprs/welcome>.
2. Select “New GPRS User Registration for COPS.”
3. Fill in the required information. Note: Recipients with both OJP/OVW and COPS active awards are required to create separate accounts with a unique GPRS username for each. The accounts can then be consolidated into one username (your choice, but you must sign in with that account to consolidate usernames).
4. Click “Award Selection.”
5. Enter your COPS Office vendor number (a 9-digit number, which can be found on your award documents), and click “Add Vendor.”
6. A listing of all awards associated with this vendor number will display on the bottom half of the screen.
7. Use the check boxes to the left to identify the awards for which you would like to have drawdown access.
8. Click “Submit Registration.”

You will receive a confirmation email with a temporary password after your request has been reviewed and approved. Do not register a second time while your request is being reviewed. Once you receive the email, you should login to the GPRS system immediately (<https://grants.ojp.usdoj.gov/gprs/welcome>) by entering the username you selected and the temporary password to receive via email. The system will instruct you to change your password to something permanent. Please read the password restrictions when creating your permanent password.

From there, you should have access to draw down from the accounts that you have selected. If you do not receive your temporary password within 2 business days, please check your junk mail box. You also have the option to use the “Forgot Password” link on the webpage. It will email you a new temporary password that you will need to change to a permanent password.

Keep in mind, these passwords are temporary, so you must log in and change them as soon as possible. If this does not work, please contact the GMS Helpdesk (888-549-9901, option 3) for a password reset for GPRS with the username you selected upon registration.

To add an award to an existing COPS username GPRS account:

If you are currently registered for an active COPS Office award username in GPRS and would like to add a recently funded COPS Office award number to your existing COPS Office award username, contact the

COPS Office GPRS registration team via e-mail at COPSGPRSRegistration@usdoj.gov and provide the following information:

- COPS award Username (for COPS Office awards)
- First/last name
- Vendor number (as listed on your award document)
- Award number(s) to be added

Instructions for Removing Old Users

COPS Office Agency Portal

To remove users:

1. Call the COPS Office Response Center at 800-421-6770.
2. Provide the names of the users you want to remove from accessing the COPS Office Agency Portal. You must give a reason and provide proof of the change.

To remove the LE or GE:

1. Call the COPS Office Response Center at 800-421-6770.
2. Provide a “Change of Information” (COI) form to the Response Center point of contact, along with the contact information for the new LE/GE.
3. The COPS Office Response Center will send a new registration letter via e-mail.
4. The new LE/GE will register on the COPS Office Agency Portal.

Grant Payment Request System (GPRS)

To remove users:

1. Send an e-mail to COPSGPRSRegistration@usdoj.gov, and state that you have GPRS users who can be removed. Please ensure you remove users who are no longer affiliated with the COPS Office grant.
2. Identify yourself as a current user of the GPRS system.
3. Provide the account usernames and the names of the individuals, along with the reasons for removals.

4. Filing Reports

8. Closeout of Grants


An essential part of any federal grant program is a proper programmatic and financial "closeout" of each award at the end of the grant period. The COPS Office has created a closeout process to expedite the closure of our grant awards and contacts grantees when their awards are due to close. During the closeout process, the COPS Office will determine whether your agency has met and fulfilled all of the programmatic and financial requirements and conditions of your grant.

Grantees can prepare for the closeout of their award(s) by saving all pertinent paperwork associated with the closing grants. In addition, grantees must submit a final Federal Financial Report (SF-425) for your grant, which is due to the COPS Office after the end of the grant period. Your SF-425 should reflect the total amount of federal expenditures, the total amount of agency matching contributions (if applicable), and the amount of unobligated funds, if any. Any unobligated or unspent funds will be de-obligated during the closeout process.

Please note that all documentation associated with a COPS Office grant must be saved for at least three years following the closure of the grant award.
