**For the At Large District of District of Columbia**

To Date, \$92,369,547 in COPS grants were awarded to law enforcement agencies in the At Large District of District of Columbia

## ***Highlights***

- COPS grants have funded 799 additional police officers and sheriffs deputies to engage in community policing activities, including crime prevention, in the At Large District.
- 18 local and state law enforcement agencies in the At Large District have directly benefited from funding made available through the COPS Office.
- \$12,898,723 has been awarded for crime-fighting technologies. This funding has allowed officers to spend more time on the streets of the At Large District of District of Columbia fighting and preventing crime through timesaving technology, information-sharing systems, and improved communications equipment.
