



Force**

Utah County Information:

- 2, 143 Square miles.
- 44 miles South of Salt Lake City.
- Second most populated county in the state. (First is Salt Lake County).
- Estimated population in 2006 was 530,837. (just under 3 million state-wide)
- Provo City is the most populated city in Utah County with 113,984 (est. 2006).
- 17 total Law Enforcement Agencies: Sheriff's Office, 14 different city agencies, Brigham Young University Police, Utah Valley University Police.



UTAH VALLEY SPECIAL VICTIM'S TASK FORCE

- **The Task Force is made up of various Detectives from all Law Enforcement Agencies in Utah County.**
 - Utah County Sheriff's Office is the supervising agency. The current director is Lt. Mike Brower.
 - Responsible for the investigation of all sexual and most physical abuse cases that occur in Utah County.
 - Allows for the sharing of resources and more man power to all agencies.
- **Federal agencies are also part of the Task Force.**
 - FBI, U.S. Marshall's, I.C.E.
- **Various civilian agencies are also part of the Task Force.**
 - DCFS, CPS, Children's Justice Center, Victim Advocates, Utah County Attorney's Office, etc...

UTAH VALLEY SPECIAL VICTIM'S TASK FORCE

- **Utah County Sheriff's Office personnel assigned to the Task Force:**
 - 1 Lieutenant.
 - 1 Sergeant.
 - 3 Detectives.
 - 3 Victim Advocates.
 - 2 Sex Offender Compliance Specialists.
- **Over 50 individuals total assigned to the Task Force from other Law Enforcement and civilian agencies.**

Due to the Grant...

- **One of the Detective positions was going to be lost due to budget cuts.**
- **The Grant allowed the Sheriff's Office to retain one of the Detective positions.**
- **The Grant allowed for this Detective position to become more “proactive” and less “reactive”.**
- **Due to experience, training, and expertise, the senior Detective was assigned to this position.**
 - **Main responsibilities include various types of computer crimes that are sexual in nature and non-compliant sex offender cases.**

Grant Success Case Example:

- **Detectives made a “Direct Connect” on-line with an individual who is an avid collector of child pornography.**
- **Using the information located during the forensic investigation, Detectives obtained a search warrant for the individual’s residence, computer, and related equipment.**
- **The warrant was served and as we walked in, the suspect was in the process of down-loading child pornography.**
- **Suspect then “met” our wonderful FBI agent. Detectives and Agent Nordstrom obtained a confession.**
 - **Can you say “indictment”?**
- **Additional man power provided by the Grant has allowed for more proactive efforts by Detectives which otherwise would have been impossible.**

Grant Success Case Example:

- **March, 2011: Operation “Frosty-Lime Squeeze”.**
 - **Month long operation initiated by Utah Attorney General’s Office. Thirty-seven total arrest State wide.**
- **"If a person spent eight hours a day, in chunks of 15 seconds downloading and viewing each image seized during this operation, the person would be viewing child pornography non-stop for 55 years," says Ken Wallentine, Director of Law Enforcement for the Attorney General’s Office. "We could probably add a few more years for all of the images found on cell phones and Xboxes."**
- **Utah County responsible for 11 individuals being arrested.**
 - **12 residential search warrants resulting in; 23 computers seized, 18 external hard drives seized, 16 cell phones/ipods/etc., hundreds of CDs/DVDs seized.**
 - **Resulting Charges: 64 sexual exploitation of a minor, 3 aggravated sexual abuse of a child, 9 sexual abuse of a child, 1 sodomy of a child, 1 manufacture and distribution of child pornography.**
- **Jeremy Hanks is a convicted serial rapist who was released November 2010 after serving about 15 years in prison. Hanks is now facing federal charges after investigators seized four computers, three cell phones, four hard drives and ten memory storage devices with child pornography at his Pleasant Grove home. Two other adults were arrested for drugs and child endangerment.**

OPERATION FROSTY LIME SQUEEZE IS THE LARGEST OPERATION IN THE HISTORY OF THE UTAH INTERNET CRIMES AGAINST CHILDREN TASK FORCE. ICAC, ITS AFFILIATES AND SUPPORTING AGENCIES SEIZED 124 COMPUTERS AND 118 EXTERNAL HARD DRIVES DURING THE OPERATION WHICH IS EQUAL TO A STACK OF DOCUMENTS 10,079,300 FEET TALL. THAT'S ROUGHLY 1,909 MILES, OR 347 TIMES HIGHER THAN MT. EVEREST.



UTAH VALLEY SPECIAL VICTIM'S TASK FORCE

UTAH VALLEY SPECIAL VICTIM'S TASK FORCE

- **Approximately 468 convicted sex offenders in Utah County.**
- **There are approximately 380 sex offenders not currently supervised by Adult Probation and Parole agents. The Task Force is responsible for keeping track of those sex offenders not supervised by AP&P.**
 - **Sheriff's Office is responsible for registering approximately 360 of these. (Approximately 20 of these are registered by local police agency)**

UTAH VALLEY SPECIAL VICTIM'S TASK FORCE

- In 2006, there was only one Sex Offender Compliance Specialist.
- In 2006, the Task Force became very proactive in sex offender compliance:
 - 53 non-compliant sex offenders arrested and prosecuted in 2006.
 - 18 non-compliant sex offenders arrested and prosecuted in 2007.
 - 19 non-compliant sex offenders arrested and prosecuted in 2008.
 - 5% non-compliant rate for Utah County compared to 43% State-wide.
- Things looking great??????

UTAH VALLEY SPECIAL VICTIM'S TASK FORCE

- **The Grant allowed the Sheriff's Office to hire an additional Sex Offender Compliance Specialist.**
- **Various older court documents were searched by staff in an attempt to locate individuals that had been convicted of sex offenses but had previously gone unnoticed to the Utah Sex Offender Registry.**
- **Due to the additional man power provided by the grant, 39 non-compliant sex offenders were arrested in 2009 and 25 were arrested in 2010.**

The Grant Has Allowed Us To:

- **Retain/Hire additional staff.**
- **Attend training and obtain equipment to assist us in our proactive efforts.**
- **Keep the citizens in Utah County safe from child predators.**
- **Proactively monitor/investigate cyber sex crimes.**
- **Locate and arrest non-compliant sex offenders.**
- **Foster relationships with Local and Federal Agencies.**

- Creates National Standards for sex offender registration and notification (SORNA)
- A powerful tool for assisting states in locating, apprehending, and prosecuting sex offenders

USMS Role

“In order to protect the public from sex offenders and offenders against children...” (section 102)

*The “Attorney General shall use the resources of Federal law enforcement, including the United States Marshals Service, to **ASSIST** jurisdictions in locating and apprehending sex offenders who violate sex offender registration requirements.” (section 142)*



Success Story

Manchester, NH P.D.

- Manchester, NH PD granted COPS funding in FY09 (\$ 380,937.00) for 2 years
 - USMS provided \$35,800
- USMS/Manchester PD planned & executed a long term joint sex offender apprehension operation for the City of Manchester
- Non-compliant sex offenders identified, investigated, and apprehended from Oct 09 – Sept 11
- Agencies included:
 - Manchester PD / NH State Police
 - USMS & USAO
 - NH Probation and Parole
 - Hillsborough Co. Sheriff's Dept and Attorney's Office
- To date:
 - 60 non-compliant sex offenders have been arrested,
 - 1 AWA case was filed in the D/NH
 - 1263 sex offender compliance checks were conducted

Success Story

Idaho Sex Offender Watch TF

- Three proposals combined into one unified task force (ISOW-TF)
 - Canyon County Prosecutor's Office
 - USAO / USMS
- Reduce and prevent child endangerment by protecting communities from sexual predators.
- Awarded grant in the amount of \$493,000.
 - Operational funding for enforcement work
 - 1 fulltime prosecutor (Special Assistant AUSA)
 - 1 fulltime investigator (Special DUSM)
 - equipment , infrastructure, overtime, training, travel
- 3 person Executive Board governs the ISOW-TF
 - meets monthly
- April 2011 - hosted the Idaho Sex Offender Watch Conference,
 - attended by over 200 personnel from 65 different agencies
- June 2011 - Operation 2nd Go Around – over 900 sex offenders verified their compliance




Sex Offender Tracking Team

- Conduct searches on non-compliant offenders, develop packages of leads, to include:
 - Mapping alternate addresses of non-compliance (homes of family members, past/present associates, other ties)
 - Producing timelines of an offender's history, including places of residence, employment and travel
- Conduct internal searches for possible linkages of non-compliant sex offenders to NCMEC cases of child abduction, online exploitation, and attempted abductions

In Public Records We May Find...

- Addresses, telephone numbers, cellular phone numbers
- Alias names, DOBs, Social Security Numbers
- Relatives, associates and business partners
- Businesses, employment, tax liens and judgments
- Vehicles, property, licenses and voter registration
- Limited criminal history information



NCIC Offline Searches

- SOTT Analysts can run two types of Offline searches:
 - Transactional logs: Logs show every instance in a given time frame when law enforcement has run a query in NCIC for the individual in question
 - Purge checks on missing/wanted files: Provides a record of any files that are active or that have been pulled for wanted/missing persons or property
- Requests are submitted to the FBI through LEO. Unless urgent, results can take 1-3 days for processing on their end. (LEO personnel only available Monday-Friday unless emergency.)

Internet Searches

- Internet searches allow us to locate a wide range of information to include:
 - Personal blogs, images, videos, self promotion, etc.
 - Gang related information, tattoos, signs, etc.
 - School/business contact information
- Specialized website searches:
 - Sex Offender Public Websites: are they compliant in another state?
 - USPS: verify valid/invalid/undeliverable addresses
 - DOC: additional criminal information
 - Payphone information
 - Craigslist/eBay postings
 - Car rental information
 - And much, much more...




