### **PRIVACY CONSENT, WAIVER, AND RELEASE AUTHORIZING USE AND DISCLOSURE OF PHOTOGRAPHIC IMAGE**

#### **Notice to Individuals**

The United States Department of Justice (DOJ), Office of Community Oriented Policing Services (COPS Office), is seeking photographs from law enforcement agencies for the Community Policing in Action Photo Contest. There is no cash award or other prize associated with the photo contest. Selected photographs may be featured in DOJ press releases, web content, e-newsletters, publications, presentations, documents, reports, and social media posts for official business purposes. Selected photographs will be disseminated to the public via DOJ websites, or DOJ's authorized accounts on third party websites (including, but not limited to, Facebook, YouTube and Twitter), or in any other media format. The collection of photographs for the photo contest is authorized pursuant to 5 U.S.C. § 301, 44 U.S.C. § 3101, and the Violent Crime Control and Law Enforcement Act of 1994, Pub. L. No. 103-322, 108 Stat. 1796 (1994). The photographs will be used and disseminated primarily to support DOJ's missions, including enabling the COPS Office to advance the practice of community policing by the nation's state, local, territorial, and tribal law enforcement agencies through information and grant resources. Providing permission to DOJ to use your photographic image is entirely voluntary.

#### **Consent, Waiver, and Release by Individuals**

**I Authorize** DOJ to collect photograph(s) containing my photographic image from law enforcement agencies for the photo contest and use, disclose, and disseminate my photographic image to the public to support DOJ's missions as stated above.
