A TRIBAL RESOLUTION OF THE MUSCOGEE (CREEK) NATION APPROVING THE DEPUTATION AGREEMENT BETWEEN THE BUREAU OF INDIAN AFFAIRS, THE STATE OF OKLAHOMA, SUBDIVISIONS OF THE STATE OF OKLAHOMA AND THE NATION AND AUTHORIZING THE PRINCIPAL CHIEF TO EXECUTE JAIL AGREEMENTS WITH LOCAL AGENCIES

Be it resolved by the National Council of the Muscogee (Creek) Nation:

WHEREAS, the McGirt/Murphy decision of the United States Supreme Court will increase the number of individuals subject to the criminal jurisdiction of the Nation with respect to criminal acts committed by Native American Indians, criminal acts with Native American Indian victims and domestic violence acts with Native American Indian victims; and

WHEREAS, the Nation executed a *Deputation Agreement* with the Bureau of Indian Affairs ("BIA") pursuant to TR 12-065 on November 20, 2013; and

WHEREAS, the intent of the *Deputation Agreement* is to provide cross deputation of law enforcement officers so that they will be authorized to assist the BIA in its duties to provide law enforcement services to make lawful arrests in Indian Country within or near the jurisdiction of the Nation; and

WHEREAS, the *Deputation Agreement* provides that pursuant to an appropriate tribal resolution, any law enforcement agencies will also be authorized to enforce tribal law; and

WHEREAS, the Nation desires to enter into Jail Agreements with the City of Tulsa, the County of Tulsa, the County of Muskogee, and others as needed, for jail services; and

WHEREAS, the Jail Agreements will allow the Nation, for a certain price, to house individuals in the custody of the Nation and help to prevent the over-crowding of the City of Okmulgee Jail and help to the reduce the transportation costs of the Lighthorse Police; and

WHEREAS, Article VI, § 7, of the Constitution of the Muscogee (Creek) Nation states that the National Council has the power to legislate on matters involving negotiations with other governments.

NOW THEREFORE BE IT RESOLVED THAT, the National Council hereby approves the Deputation Agreement between the Bureau of Indian Affairs, the State of Oklahoma, the subdivisions of the State of Oklahoma and the Nation in order to authorize Law Enforcement Officers to assist the Bureau of Indian Affairs in its duties to provide law enforcement services and make lawful arrests in Indian Country within or near the iurisdiction of the Nation.

BE IT FURTHER RESOLVED THAT, this Tribal Resolution shall act as authorization for participating law enforcement agencies to enforce tribal law as required by the Deputation Agreement.

BE IT FURTHER RESOLVED THAT, the National Council hereby authorizes the Principal Chief to execute Jail Agreements with the City of Tulsa, the County of Tulsa, the County of Muskogee, and others as needed, to assist with housing individuals in custody of the Nation.

BE IT FURTHER RESOLVED THAT, the National Council authorizes the Principal Chief to execute future Jail Agreements provided that the agreements do not waive the sovereign immunity of the Nation and are first reviewed by the Office of the Attorney General.

BE IT FURTHER RESOLVED THAT, the Principal Chief's authority to enter into these agreements without National Council approval as provided by this Tribal Resolution shall expire in three months after certification of the Tribal Resolution. Upon expiration, all future Deputation Agreements with the State of Oklahoma and the subdivisions of the State of Oklahoma shall be approved by Tribal Resolution. Also, all future Jail Agreements, if necessary, will be subject to approval by Tribal Resolution.
